

## FAMILY DOCUMENT CHECKLIST

This family documents checklist from JMA is a good starting point. Make any necessary additions and skip items that don't apply. You should make sure the item on the list are easy to find, ideally organized in a fireproof filing cabinet or home safe. JMA suggests you complete the checklist—listing locations and comments next to each item—and send copies to the executor of your estate and to key family members.
